THE FOOD BOOTH & VENDORS FEE OF \$100.00 WILL BE CHARGED. THIS FEE WILL COVER THURSDAY, FRIDAY AND SATURDAY. FOOD BOOTHS WILL NEED TO BE OPEN AND RUNNING BY 4:00 P.M ON THURSDAY AND FRIDAY, CLOSE AFTER RODEO EVENTS. THE BOOTHS WILL NEED TO REOPEN SATURDAY AT 3:00 P..M. AND RUN THROUGH MIDNIGHT. THERE ARE DANCES THURSDAY, FRIDAY AND SATURDAY NIGHTS AND WE WOULD LIKE THE FOOD BOOTHS TO BE OPEN SO THE PEOPLE CAN PURCHASE FOOD AND MERCHENDISE FROM THE VENDORS.

LIMITED ELECTRICITY IS AVAILABLE. (ONLY 110 OUTLETS IF THE ELECTRICITY IS TAMPERED WITH THE VENDOR IS SUBJECT TO LEGAL PENALTIES). TRAILER SPACE IS LIMITED TO A 12X12 SPACE. THE COMMITTEE WILL REVIEW THE NEED FOR EXTRA SPACE IF NEEDED FOR YOUR TRAILER THERE WILL BE AN ADDITIONAL CHARGE OF \$25.00. (IF YOU KNOW YOUR TRAILER IS BIGGER THAN PLEASE PAY THE ADDITIONAL COST UP FRONT.)

All food vendors must comply with State, County and City permit requirements.
YOU WILL BE ASKED TO LEAVE IF YOU DO NOT PROVIDE PROOF OF THE PERMITS

VENDORS MUST TAKE CARE OF THEIR AREA AND ALL VENDOR TRASH WILL BE REQUIRED TO BE PUT INTO THE BFI DUMPSTERS BY THE VENDOR. CITY PENALTIES OR FINES COULD BE \$500.00
